TERMS & CONDITIONS

Modern Beauty distributes professional products to salons, spas, and tanning studios for the purpose of resale or professional usage. The Modern Partnership Program is available to salon owners. Participants are required to be 100% committed to 1 or more professional color brands, it's corresponding retail brand and two additional retail brands. Salon may qualify only using one retail brand if that is the sole brand in the salon.

Rewards Redemption: A minimum inventory purchase of \$2,000 is required quarterly in order to be eligible for the rewards. The salon must evenly distribute the rewarded amount amongst the retail lines carried. Color cannot be purchased using rewards. All tools and products purchased using reward dollars are not for resale and are for station use only (tools will be shipped without packaging). All rewards dollars are deemed to be at regular price. Rewards expire 30 days after the end of each quarter.

Education: Education discounts are only applicable towards education events hosted by Modern. The rewards discount is valid for the entire quarter and the education percentage discount applies to the total cost of classes. The education discount for the current quarter is based on the previous quarter earnings level.

Earnings: Rewards are non-transferable, have no cash value and cannot be used as payment of obligation. Earnings are accumulated quarterly (over a 3 month period) and expire 30 days after the end of each quarter. No abuse of the program will be tolerated, and failure to follow the Modern Partnership Program terms will result in an annulment of the program, no additional points will be rewarded and all unredeemed points will be forfeited. Two Modern Partnership Programs cannot be combined into one account. All awarded rewards must be used in one transaction, one order for retail rewards and one for bonus rewards. Anything short of the total reward amount will be discarded and no roll overs are permitted.

Account: The Modern Beauty client must keep account current at all times, otherwise the participant will be ineligible to redeem rewards and all accumulated rewards from the Modern Partnership Program will be terminated.
